1. Purpose

In this instance your data is being processed for the specific purpose of managing your employment.

2. Lawful Basis

The collection of your data for this purpose is under the Lawful Basis of Contract because we require to process this data in order to manage your contract of employment with Districts Properties Ltd Trading as Districts London.

4. Retention

Under the Lawful Basis referenced in paragraph 2, your data will be retained until the date your employment ceases with the Company and then for a further 6 years thereafter, in accordance with CIPD advice.

5. Destruction

At the end of this retention period your data will be destroyed using an approved method unless prevented by Court order.

6. Data Sharing

Whilst we control your personal data we will need to share this data with the following parties, for the following purposes, in order to provide you with the services you are seeking from us:

- 6.1. Parties whose details have been given to Districts Properties Ltd Trading as Districts London by the data subject for referencing purposes.
- 6.2. Bespoke HR Ltd for the provision of Human Resourcing advice.
- 6.3. KBSP LLP for the provision of payroll services.
- 6.4. HSBC, the Company's bankers in order to pay your salary.
- 6.5. Nest Pensions, for the sole purpose of administering employee's pensions.

6.6. Computerate in conjunction with the IT support services they provide to Districts Properties Ltd Trading as Districts London, which enable to storage and processing of data.

7. Rights of the Data Subject
